#### (For Academic Year 2024, 2025 & 2026)

Online applications are invited from interested and eligible candidates for admission in Ph.D. Programme against the vacancies in various subjects for the academic year 2024, 2025 & 2026 in accordance with Bihar State Universities Ph.D Ordinance and Regulation 2026 notified by Governor's Secretariat, Bihar vide its letter no. L/ORD./02/2026-1412/GS(I) dated 04.07.2026. ### **Eligibility Criteria & Assessment:**

1. A Master's Degree (2-year/ 4 semester) with at least 55% marks or its equivalent grade 'B' on the UGC 7-point scale (or an equivalent grade in point scale wherever the grading system is allowed) in the subject.
2. A relaxation of 5% marks (i.e. from 55% to 50%) or an equivalent relaxation of grade is available to SC/ST/EBC/BC (Non-Creamy Layer)/ Person with a disability categories as per the State/University rules. A candidate seeking admission after a 4-year/8-semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed.
3. The Chancellor's Secretariat, vide its letter no. L/ORD./02/2026-1412/GS(I) dated 04.07.2026, has notified the Bihar State Universities Ph.D Ordinance and Regulation 2026 according to which admission to Ph.D will be strictly limited to the students who have qualified the UGC NET/GATE/CSIR Exam. the National Eligibility Test (NET) score will be used for admission to Ph.D. programs in place of entrance tests conducted by the different Universities in Bihar.

### **The NET candidates will be declared eligible in three categories:**

**Category-1:** Eligible for (i) admission to Ph.D. with JRF and (ii) appointment as Assistant Professor.

**Category-2:** Eligible for (i) admission to Ph.D. without JRF and (ii) appointment as Assistant Professor.

**Category-3:** Eligible for admission to Ph.D. programme only and not for the award of JRF or appointment as Assistant Professor.

Merit List will be prepared on the basis of NET Score in each category. Final selection to the Ph.D. will be based on NET Score and Interview Marks. 80% weightage will be given for NET scores 20% weightage for the interview for admission to Ph.D. program. The validity of the NET Score for the category 1 & 2 will be one year from the date of declaration of NET Result.

### **Note:**

- The University reserves the right not to offer the Programme in any particular discipline on administrative reasons or if the response to the Programme is not adequate. The decision of the University will be final in this regard.
- The University reserves the right to change the number of seats in any



Programme. It will be accordingly notified on the University website.

- Regular Teachers & Non-Teaching staffs of Munger University, Munger and its constituent colleges who fulfill the require criteria for admission to Ph.D as per clause 3 & 5 of Bihar State Universities Ph.D Ordinance and Regulation 2026 can apply for Regular (Full time) Ph.D programme as supernumerary candidate. They shall submit the No Objection Certificate (NOC) from their concerned Head/Principal alongwith the application form as prescribed in clause 6.3 of Bihar State Universities Ph.D Ordinance and Regulation 2026.

### GUIDELINES FOR PART-TIME Ph.D. AT MUNGER UNIVERSITY, MUNGER

As per the Clause No.6.2.1 of Bihar State Universities Ph.D Ordinance and Regulation 2026 notified dated 04.07.2026 Ph.D. through part-time mode is permitted, provided all the conditions stipulated in these Regulations are fulfilled.

1. Requirement of NOC: An employed candidate from the University/Government Institution/PSU/Armed Forces/Private Sector listed under BSE or NSE applying for part-time Ph.D. programme at Munger University, Munger, who have **completed at least two years of continuous service in their organization**, shall submit a "No Objection Certificate" from the Head of the organization where she/he is employed, clearly stating that:
  - (i) The candidate is permitted to pursue studies on a part-time basis;
  - (ii) The official duties of the candidate permit her/him to devote sufficient time for research.
  - (iii) If required, she/he will be relieved from the duty to complete the coursework.
2. Fellowship/Assistantship: No fellowship or assistantship of any kind shall be awarded to the candidates pursuing Ph.D. degree in the part-time mode.
3. Eligibility Criteria: The eligibility criteria for admission to the part-time Ph.D. programme shall be as per the clause no. 3 & clause 5.1 of Bihar State Universities Ph.D. Ordinance and Regulation 2026 .
4. Programme Duration: The duration of the Full time as well as Part-time Ph.D. programme shall be as per the clause no. 4 of Bihar State Universities Ph.D. Ordinance and Regulation 2026.
5. Admission Procedure: The admission procedure of the part-time Ph.D.



programme shall be as per the clause no. 5.1 & 5.2 of Bihar State Universities Ph.D. Ordinance and Regulation 2026.

6. Allocation of Supervisor: The allocation of research supervisor/co-supervisor of the Full time as well as Part-time Ph.D. programme shall be as per the clause no. 8 of Bihar State Universities Ph.D. Ordinance and Regulation 2026 and as per university rules.
7. Coursework: The coursework in the part-time Ph.D. programme shall be as per the clause no. 11 of Bihar State Universities Ph.D. Ordinance and Regulation 2026 and as per university rules. The coursework is a prerequisite for Ph.D. The credit requirement for the Ph.D. programme is 12-16 credits. Students who have registered for Ph.D. have to take the topic offered by the Department.

The duly filled up and completed forms can be submitted online along with supporting documents and requisite fee **from 08/08/2026 to 25/08/2026 (without late fine) and with late fine till 27.08.2026 (late fine Rs. 200/-)**. Incomplete application form will be summarily rejected.

- Category (SC/ST/OBC-NCL/EWS) certificate / PH certificate issued by competent authority.
- Employer's NOC (if employed and applying for Part-Time Ph.D.)
- Any other relevant certificates (JRF/Research Fellowship/M.Phil certificate/Publications/Proof of Munger University Regular Teaching Non-Teaching staff if applicable).

**Note:-**

75% attendance is mandatory for the the Ph.D. programme for candidates applying for Ph.D. in Regular mode (Full time). Moreover, a candidate has to submit "**NO OBJECTION CERTIFICATE**" from the Institution/ Employer if he/she is a Govt./PSU/Private undertaking employee at the time of seeking admission under Part-time Ph.D in the University.

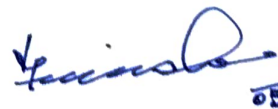
