In pursuance of the Sankalp No. 1594 dtd. 20.08.2014 and No. 15/2-2014-925 dtd. 13.04.2021 of Education Department, Government of Bihar, Patna, advertisement for engagement of Guest Faculty in various subjects under Munger University was published in daily news papers and on the official website of Munger University vide advt. No. EstB/2148/2022 dtd. 07/04/2022. The Vice Chancellor, on the recommendation of duly constituted selection committee, is pleased to appoint following persons as Guest Faculty in **Political Science** subject, purely on temporary basis on a fixed honorarium of Rs. 1500/-per class for eleven months, with a maximum of Rs. 50000/- in a month.

The tenure of engagement of the Guest Faculty shall not be more than one academic session (equivalent to 11 months). On the basis of performance evaluation report and recommendation of the concerned Principal of the College, their services may be renewed for next tenure as per norms.






